## B. GENERAL COMPETITION RULES

2. 3. This competition is in no way sponsored, endorsed, administered by or associated with Facebook, Twitter, Instagram and/or any relevant other social media site(s).
4. By entering the competition, each person participating in this competition ("Participant") acknowledges that he/she has read and understood the General Competition Rules and the Terms of Use, and agrees to be bound thereby.
5. All competitions shall contain the relevant entry and participation information either contained in these Competition Rules, or in competition information published pursuant to a competition, which information shall include:

34. Patriot reserves the right, at its discretion, to change any prize, at its sole discretion.
